Minutes of the Annual Meeting of Earley Town Council held in the Council Chamber, Council Offices, Radstock Lane, Earley, Berkshire on Wednesday, 15th May 2019 which commenced at 7.45pm.

The first fifteen minutes of the meeting were set aside for members of the public to pose questions to the Council. There were no questions and the meeting started forthwith.

1. TOWN MAYOR

The outgoing Town Mayor, Councillor B Wedge, addressed the Council and said that he had very much enjoyed his term of office as Town Mayor. He had attended numerous interesting and enjoyable events during the year and had felt that it was an honour to represent the residents of Earley.

The outgoing Town Mayor then called for nominations for the office of Town Mayor for 2019/20.

There was one nomination. After being duly proposed and seconded it was

<u>**RESOLVED**</u> – that Councillor David Hare be elected to the office of Town Mayor and Chairman of the Council for the ensuing Municipal Year.

Councillor David Hare signed his Acceptance of Office, received of the Mayoral Chain of Office and took the Chair.

2. **DEPUTY TOWN MAYOR**

The newly elected Town Mayor asked for nominations for the position of Deputy Town Mayor for 2019/20. There being two nominations proposed and seconded, a vote was held and it was
