35. <u>ESTIMATES</u>

35.1 Financial Year 2018/19

37. REQUESTS FOR FINANCIAL ASSISTANCE

37.1 Wokingham Sports Partnership

Members were reminded that, on previous occasions, the Town Council had, under Section 137, match funded the contribution made from the Wokingham Sports Sponsorship Fund to various young people within the area. A request for further funding had been received from Wokingham Borough Council and, in accordance with the wishes of Members, the letter containing the names of the recipients had been appended to the Agenda.

RESOLVED that in accordance with the provisions of the Local Government Act 1972, Section 137, as amended by the Local Government Housing Act 1989, Section 36, a contribution of £1,050 be made to the Wokingham Sports Sponsorship Fund.

37.2 Grant Applications

Consideration was given to a schedule of grant applications, as previously circulated to Members, which detailed the level of funding awarded in previous years and the amounts requested by the various organisations for 2018/19.

Declarations of interest were declared by Councillor Pauline Jorgensen in connection with Revitalise and Councillor Michael Firmager in connection with ARC and The Link Visiting Scheme.

It was noted that both ARC (youth support) and the Wokingham branch of the Citizens Advice Bureau had requested larger donations than in previous years. With regard to the application from Revitalise, although Members were of the opinion that it was a good cause, it was felt that the Town Council did not have the resources to be able to donate to that particular organisation. In consideration of the application from Sue Ryder – Duchess of Kent Hospice and The Link Visiting Scheme it was noted that the applications lacked clarity with regard to the specific connection with Earley. With regard to the application from Revitalise, Members noted that less than 1% of Earley residents benefited from the service.

RECOMMENDED that, subject to budget approval, in accordance with the provisions of the Local Government Act 1972, Section 137, as amended by the Local Government Housing Act 1989, Section 36, contributions be made to the various applicants as set out below:-

- 4. box 9 on the Grant Application Form be altered for future years to request the total number of people helped and the total number of Earley residents helped.
- 5. A total sum of £2,000 be allocated to Citizens Advice Bureaux, to be apportioned by the Town Clerk to reflect the proportions of Earley users at each of the two CABs.
