



1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2018/19

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 3 has been incorrectly completed and should have been answered 'No' in the light of the internal auditor's findings. The internal auditor answered 'No' to internal control objective G on the Annual Internal Audit Report since they concluded that PAYE and NI requirements were not properly applied to some salary payments during the year.
