

# **EARLEY TOWN COUNCIL**

Minutes of the Annual Meeting of Earley of Town Council held in the Council Chamber, Council Offices, Radstock Lane on Wednesday 8<sup>th</sup> May 2024 which commenced at 7.00pm.

#### Present

#### 1. <u>ELECTION OF TOWN MAYOR</u>

The outgoing Town Mayor, Councillor Caroline Smith thanked councillors and council officers for the support she had received during her enjoyable time as Town Mayor. Members also noted the outgoing Town Mayor's recent engagements which included a visit to a hospital radio, a night in a cell at Thames Valley Police and the Annual Town Electors' meeting.

1.1 The outgoing Town Mayor called for nominations for the office of Town Mayor for the municipal year 2024/25. A nomination for Cllr Mike Smith was proposed and seconded. There were no other nominations. It was:

**RESOLVED** that Cllr Mike Smith be elected to the office of Town Mayor (Chair of the Council) for the municipal year 2024/25. There were 2 abstentions.

1.2 The newly elected Town Mayor signed the Declaration of Acceptance of Office, received the Chain of Office from Cllr C Smith and assumed the position of Chair.

# 2. <u>ELECTION OF DEPUTY TOWN MAYOR</u>

2.1 The Town Mayor called for nominations for the office of Deputy Town Mayor for the municipal year 2024/25. A nomination for Cllr Nicola Brock was proposed and seconded. There were no other nominations. It was:

**RESOLVED** that Cllr Nicola Brock be elected to the office of Deputy Town Mayor for the municipal year 2024/25. There were 3 abstentions.

2.2 The Town Mayor presented the Deputy Town Mayor with the Chain of Office.

Councillor Khayinza entered the meeting.

# 3. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors A Bradley, T Holton, M De Jong, P Jorgensen, N Jorgensen, A Long and S Newton.

#### 4. DECLARATIONS OF INTEREST

There were no declarations of interest.

### 5. PUBLIC FORUM

There were no members of the public present.

### 6. MINUTES OF THE PREVIOUS MEETING

It was **RESOLVED** that the Minutes of the meeting of Earley Town Council (127 - 146) held on 27<sup>th</sup> March 2024 were a true record and could be signed by the Chair.

# 7.1 <u>Planning Committee</u>

Cllr M Smith presented the draft Minutes of the Planning Committee meeting (Minutes 153 - 166) held on 9<sup>th</sup> April 2024.

#### 8. APPOINTMENTS

#### 8.1 Leader of the Council

The Chair called for nominations for the position of Leader of the Council, in accordance with Standing Order 5n (v and vii). One nomination was proposed and seconded. It was:

**RESOLVED** that Cllr David Hare be appointed Leader of the Council. There were 4 abstentions.

### 8.2 <u>Deputy Leader of the Council</u>

The Chair called for nominations for the position of Deputy Leader of the Council in accordance with Standing Order 5n (vi and viii). One nomination was proposed and seconded. It was:

**RESOLVED** that Cllr Tahir Maher be appointed Deputy Leader of the Council. There were 4 abstentions.

# 9. STANDING COMMITTEES

- 9.1 It was **RESOLVED** that the following Standing Committees shall continue in municipal year 2024/25:
  - Amenities & Leisure Committee
  - Policy & Resources Committee
  - Planning Committee

# 9.2 <u>Membership of Standing Committees</u>

Members noted that in accordance with Standing Order 4(d) the Town Mayor and Deputy Town Mayor shall be ex officio members of all Committees, this being in addition to the number of committee places fixed by Council.

Members considered the membership of the Standing Committees. It was noted that Councillor De Jong wished to be a member of the Planning Committee and newly appointed Town Mayor Councillor M Smith wished to remain a full member of the Planning Committee. It was:

**RESOLVED** that, subject to the amendments to the Planning Committee as detailed above, the current membership of the Standing Committees should continue for the municipal year 2024/25, or until such time that the Council agrees otherwise.

# 9.3 <u>Chairs of Standing Committees</u>

It was noted that no decision was required with regard to the chairs of Standing Committees, as under Standing Order (4e.vii), the Committees would appoint their own chair at the first meeting of the committee.

# 10. REPRESENTATIVES TO OTHER BODIES

### 10.1 Sonning & District Welfare & Education Trust

Councillors received a written report from Councillor Owen on her attendance at a meeting on 27<sup>th</sup> March 2024. Councillor Owen indicated that the Trust had not received any applications from residents of Earley and suggested that promoting the activities of the Trust may attract such applications.

#### 10.2 Kenton Road Day Centre

Councillors received a written report from Council Bassett on her attendance at a meeting on 9<sup>th</sup> April 2024.

10.3 Councillors reviewed the current representations on other bodies and the following changes were made: -

Councillor G Littler will step down from the Wokingham Borough/Parish Liaison Forum and Councillor M Smith will take his place.

The Town Clerk reminded councillors of the importance of providing reports and updates for inclusion on future Council agendas when acting as an ETC representative to other bodies.

#### 11. DEEDS

Members noted that the various deeds relating to the Council's interests in land are held by the Town Clerk as Proper Officer and are available for Members' inspection.
