6. **DOG WASTE BAGS**

To consider the continuation of the provision of dog waste bags at cost (£1 per pack of 50) to Earley residents in 2025/26. To make a recommendation to the Policy and Resources Committee.

For information: Members to note that the budget for the purchase of dog waste bags in 2024/25 was £1,000 and income, as of 3/1/25, was £460 (ie. some stock remains).

Prior to 2023/24, dog waste bags were provided free of charge. Costs were £1,000 - 2022/23; £1,000 - 2021/22; £900 - 2020/21; £1,434 - 2019/20; £1,235 - 2018/19.

7.1 <u>Desilting Works</u>

A significant amount of silt was removed from the entrapment pond, this will enable the pond to continue functioning efficiently for several years. 9.1 <u>CENTREPOINT COMMUNITY CENTRE</u>

Earley Repair Café

The Earley Repair Café continues to operate on the second Sunday of each month at Centrepoint Community Centre. Three sessions have been held so far and all of them have been well attended. The range of items residents bring in for repair continues to expand, our volunteer repairers have worked on a variety of items including garden equipment, an array of electrical items, wooden chairs, textiles and toys, Christmas decorations, bikes and so on. Visitors are led through the process by our reception volunteers and our café volunteers provide everyone with refreshments.
